- Rate 1—\$3.40 per \$100.00 value – Cars, pickups, vans, except where Rate 4 or 5 applies
- Rate 2—\$3.80 per \$100.00 value – All trailers, heavy trucks, used more than 20,000 miles annually
- Rate 3—\$1.70 per \$100.00 value – All trailers, heavy trucks, used less than 20,000 miles annually
- Rate 4—\$4.90 per \$100.00 value – Cars or pickups of which the primary driver is a single male less than age 25
- Rate 5—\$3.80 per \$100.00 value – Cars or pickups of which the primary driver is a single female less than age 25

Pre-owned vehicles shall be entered at their current value as listed in J.D. Power Used Car Guide and new cars at a fair purchase price. No vehicle, regardless of its value, shall be entered for less than a flat fee of \$15.00. Towing, recovery, or storage coverage (accident only) up to \$1,000.00 for cars, pickups, vans, and utility vehicles, and light trailers and up to \$11,000 for heavy trucks and trailers is included at no extra charge. If proper age group rate is not paid, BAA is only responsible for 50 percent of any loss. BAA reserves the right to refuse coverage for any vehicle that is deemed inconsistent with the teachings of the Church of God in Christ, Mennonite. Non-licensed drivers on public roads are not eligible for BAA coverage. Losses by non-licensed drivers, other than on public roads, shall be considered by BAA for settlement. If applicant is not 18 years of age, a parent or guardian must sign with the applicant.
