#### Brother-to-Brother Page

A young member has had several hospital stays in the last couple of years due to heart trouble and vein procedures, leaving them with a balance of more than \$48,000 that the hospital was willing to settle for \$24,000 if they could receive payment promptly in one lump sum.

A mother of four needed urgent medical care, resulting in an outstanding bill of \$24,000.

A middle-aged father was taken from his family due to cancer, leaving a young widow with a family to finish raising and bills left from his cancer care.

A member needed a defibrillator installed which left outstanding bills of around \$15,000 and continuing bills from follow-up care.

Cancer left outstanding bills of \$25,000 for another member.

Perhaps one of the most distressing and perplexing illnesses is mental illness, and more so when it strikes our children and teens.

Recently we have had several member families with this situation, requiring professional treatment to find relief and help.

This treatment is costly and has left these families with combined non-sharable expenses over \$76,000.

A teacher who loses their voice due to allergies is not a healthy situation!
Immunotherapy is not a sharable expense,
leaving this teacher with \$3,600 to pay out of their own pocket.

After living with uncontrolled asthma for years, a member found a remedy with the infusion of a new drug at the cost of \$13,000 per month, which quickly exhausts their sharing limit with CHA.

Remember that this is only a sampling of your brothers and sisters needing help. God bless you for your unselfish giving!
