#1—Traditional Sharing: As the name suggests, this is the sharing program that has been around for quite some time. In answer to the input through the years for help with allaround small to medium sized healthcare costs. the Traditional Sharing has the most extensive list of shareable items of any of CHA's sharing programs. Among other things, it includes help with well-patient checkups, diagnostic work, surgery, ambulance, emergency room, hospital stays, diabetic supplies, optional dental and vision assistance, etc. See Overview of shareable and non-shareable items for more details. Monthly share contributions vary by age, but are charged for each person in the family (except where there are 6 or more children). There is an Annual Member Responsibility (AMR) of \$1,000 per person with a maximum of \$2,000 per family. After this is satisfied, CHA shares bills at 80%, with the remaining 20% being the member's responsibility. This sharing program has a maximum shareable amount of \$40,000 per person per year, and the board of directors will continue to consider each case that exceeds this maximum and offer additional assistance where needed through the Brother-to-Brother Fund. Diabetic supply assistance as well as the optional Vision Sharing and Dental Sharing programs are available exclusively with the Traditional Sharing. As with all of the sharing programs offered through CHA, you remain personally responsible for your medical expenses. There is no guarantee that any medical expense you submit will be eligible for or receive any payment from sharing.

CHA Sharing Choices for 2020

#2—Emerald Care Sharing: This sharing program is for those who prefer to handle their own health care costs for the most part, but would like to have some help in place for major health care expenses. As with all of the sharing programs offered through CHA, you remain personally responsible for your medical expenses. There is no guarantee that any medical expense you submit will be eligible for or receive any payment from sharing. The monthly sharing amount is \$50 per unit with a maximum of 3 units per household regardless of the number of family members enrolled. Members of the Emerald Care Sharing (ECS) will an Incident Member have Responsibility (IMR) of \$5,000 per incident, meaning they are personally responsible for the first \$5,000 of each incident before it is eligible for sharing. Because all sharing under ECS is on a "per incident" basis, all bills are handled as self-pay. This means the provider will bill the member, who will assemble all bills pertaining to the incident and submit them to CHA along with the appropriate documentation as per CHA Guidelines. Once the bill has been determined to be shareable by CHA staff, CHA's repricing team will negotiate an appropriate settlement with the provider. CHA will share 100% of the approved, negotiated charges after the member's IMR has been satisfied. Payment is usually issued to the member who may then negotiate their portion of the bill if desired and issue payment to the provider. ECS shares up to an annual limit of \$100,000 per person. There is a lifetime sharing limit of \$125,000 per illness. Because of the lower cost of ECS, there is a limited list of shareable items. See Overview of shareable and nonshareable items.

#3—Diamond Care Sharing: The Diamond Care Sharing (DCS) is for those who are willing to contribute a bit more than with ECS on a monthly basis and consequently are able to submit more items for sharing from DCS. Shares for DCS are \$177 per unit per month, with a maximum of 3 units per household. The DCS has an Annual Member Responsibility (AMR) of \$1,000 per person. Incidents must exceed \$1,000 to be eligible for sharing, even after the AMR has been satisfied. As with ECS, all bills are handled as self-pay and the member is responsible to submit the bills to the office for sharing along with the appropriate documentation, where a settlement will be negotiated by our repricing team. Bills are shared at 100% on DCS after the member's AMR has been satisfied. Payment is usually issued to the member who may then negotiate their portion of the bill and pay the provider. There is an annual limit of \$200,000 per person and a lifetime limit of \$125,000 per illness. See Overview of shareable and non-shareable items for more details about what is eligible for sharing.

As with all of the sharing programs offered through CHA, you remain personally responsible for your medical expenses. There is no guarantee that any medical expense you submit will be eligible for or receive any payment from sharing.

Both the Emerald Care Sharing and Diamond Care Sharing are offered with an optional companion sharing program called ExtenCare, which offers an additional \$100,000 sharing per year. The cost of ExtenCare is \$22 per unit per month in addition to the normal shares mentioned above.
